



AUDITOR FEE SCHEDULE Community Newspapers

New CMCA participants are required to have their Initial Report audited by the CMCA Auditor. Subsequent audits may then be audited by either the CMCA Auditor or an independent chartered accountant appointed by the publisher.

Use of the CMCA Auditor is subject to auditor fees, which are payable to the auditor at the start of the audit. The annual CMCA program fee does not include the auditor fee.

Auditor fee payment must accompany the report submission and should be made payable to **TNY Consulting**. Submit auditor fee payment with initial or annual report to the CMCA office.

Please note that Auditor fee payments must include applicable GST/HST.
